PETS are not permitted in the property under any conditions.

SECURITY/DAMAGE DEPOSIT

PAYMENT

An advance payment equal to 50% of the rental rate is required at the time of booking. A final payment of 50% of the rental rate plus a refundable £150 security deposit is required 30 days before the start of your visit.

Payments can be made by bank transfer or cheque. Payment details will be sent to confirmed guests.

CANCELLATIONS

Cancellations that are made more than sixty (60) days prior to the arrival date will incur a 10% admin penalty and receive a refund of any other monies paid.

Cancellations or changes that result in a shortened stay, that are made between 30 days and 60 days of the arrival date, will be subject to a 50% cancellation charge.

Cancellations or changes that result in a shortened stay, that are made within 30 days of the arrival date forfeit the full advance payment and reservation deposit.

Cancellation or early departure does not warrant any refund of rent.

MAXIMUM OCCUPANCY

The maximum number of guests is limited to six (6) persons, with no more than 5 adults/children plus 1 infant in a cot. If a booking is found to exceed this limit then all guests may be asked to leave and will forfeit all monies paid.

AVAILABILITY

The contract is made on the understanding that the property will be available for the dates stated. In the unlikely event that the property is not available through events arising out of the control of the property owner, the property owner may be forced to cancel the booking. The hirer will be advised of such circumstances as early as practically possible and the property owner will refund all monies paid in full but the hirer will have no further claims against the property owner.

LIABILITY

The property owner shall have no liability for death or personal injury unless this results from the negligence of the property owner.

INCLUSIVE FEES

Rates include a one-time linen & towel setup.

NO DAILY HOUSEKEEPING SERVICE

FALSIFIED BOOKINGS

Any booking obtained under false pretence will be subject to forfeiture of advance payment, deposit and/or rental money, and the party will not be permitted to check in.

WRITTEN EXCEPTIONS

PARKING
